NOTIFICATION

Applications are invited from eligible Judicial Officers who have retired from the Kerala Higher Judicial Service for appointment to the post of Registrar, Kerala Lok Ayukta on re-employment basis. The appointment will be for an initial period of two years. The tenure may be extended by the appointing authority, subject to performance and institutional requirements, provided that the officer does not exceed the maximum age limit of 68 years.

Eligibility Criteria:

1. The applicant should be a retired District Judge from the Kerala Higher Judicial Service.

2. Should possess relevant experience on the judicial side and adequate administrative experience.

3. Preference will be given to candidates with demonstrable efficiency in court management, administrative responsibilities, and legal acumen.

4. Educational qualifications, service record, and prior association with any quasijudicial or statutory bodies will be considered during selection.

Selection Process:

- Shortlisting will be based on merit, administrative experience, and overall suitability.
- Only shortlisted candidates will be called for an interaction by the Selection Committee constituted for the purpose.
- The decision of the Selection Committee will be final and binding.

Age Limit:

• The applicant should not have completed 68 years of age as on the last date of receipt of applications.

Tenure & Conditions:

- The appointment is purely on re-employment basis.
- The post carries the same salary and allowances as admissible to a sitting District Judge (subject to applicable rules and regulations).
- The selected candidate will not be entitled to pensionary benefits for the period of reemployment.
- The appointment is subject to verification of antecedents and medical fitness.

Applications must be submitted in the prescribed proforma (attached herewith), duly filled in and signed, along with the following documents:

1 Copies of retirement order, PPO, and service certificate.

- 2 .Copies of educational certificates and experience details.
- 3 .Recent passport-size photograph affixed on the application.

4 .A brief note on relevant experience, including any administrative roles held.
